Bob and the Trustees met with the Prosecutors office on Feb 15 at 1pm to obtain information regarding solar farms. After a lengthy discussion the Zoning officer will contact and meet with the Zoning Commission board members along with the Prosecutor to have a better understanding before a decision can be made.

1 permit was issued at no cost-agricultural related.

Elmer Amweg Jr situation has been resolved with the Health Board, Elmer will vacate the location by April 1, 2024.

Trustee Sherman reported about the Pleasant Township mausoleum located next to Grove cemetery. All involved are working with the Prosecutors office. Trustee Flowers reported a Health Commissioner was hired. Licensing board still needs to meet.
